# MOTOR VEHICLES AND MSRP (Manufacturer Suggested Retail Price):

As of the October 1, 2024 Grand List, the Connecticut State Legislators have changed the way Motor Vehicles are valued.

Per Section 12-117A of the Connecticut State Statutes, and the March 17, 2025 Local Option, the new depreciation schedules are to be applied to the MSRP.

In addition, the new legislation allows you to appeal only the MSRP of your Motor Vehicle. High mileage, salvage vehicles, and rebuilt titles are no longer allowed to be prorated.

The Board of Assessment Appeals will be meeting on Thursday, September 11, 2025, from 4:00 pm to 6:00 pm at the Town Hall for any Motor Vehicle Appeals. The Board Of Assessment Appeals would require you to provide them with the MSRP of your vehicle.

Please be sure to have the appropriate year, make and model of the vehicle, and the VIN (Vehicle Identification Number).
